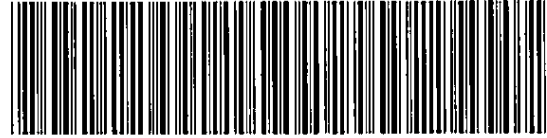

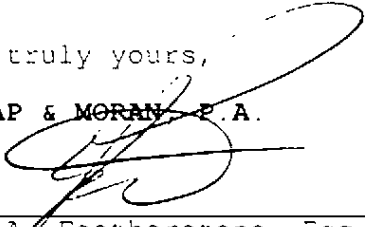

**PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

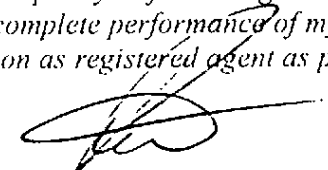
