ARTICLES OF ORGANIZATION

The undersigned, John G. Wellborn, a natural person competent to contract and an authorized representative of Live Well Brand Holdings, LLC, hereby presents these Articles of Organization as the Articles of Organization of Live Well Brand Holdings, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Live Well Brand Holdings, LLC. This limited liability company is referred to in these Articles of Organization as the “Company.”
