**ARTICLES OF ORGANIZATION

The undersigned, Charles W. Rigdon, a natural person competent to contract and an authorized representative of CLBT Investments LLC, hereby presents these Articles of Organization as the Articles of Organization of CLBT Investments LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is CLBT Investments LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and initial principal address of the Company is 506 Harbor Boulevard, Destin, Florida 32541. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

ARTICLE VI - MANAGEMENT

The Company shall be managed by one or more managers in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial manager of the Company is as follows:




