

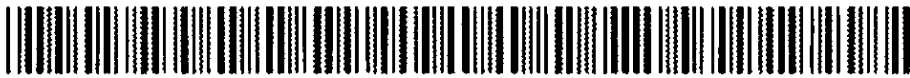

**ARTICLES OF ORGANIZATION
OF

The undersigned hereby submits these Articles of Organization (these "*Articles of Organization*") for purposes of forming **Ferdinand & Luigianna Holdings, LLC**, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company formed pursuant to the filing of these Articles of Organization is **Ferdinand & Luigianna Holdings, LLC**, a Florida limited liability company (the "*Company*").

ARTICLE II - ADDRESS

The mailing address of the Company is 860 Dyson Drive, Winter Springs, Florida 32708 and the street address of the principal office of the Company is 860 Dyson Drive, Winter Springs, Florida 32708.

ARTICLE III - INITIAL REGISTERED AGENT AND OFFICE

The name and Florida street address of the initial registered agent of the Company is **NRAI Services, Inc.**, at 1200 South Pine Island Road, Plantation, FL 33324.

ARTICLE IV - ADOPTION OF OPERATING AGREEMENT

The Company shall be governed by a written operating agreement adopted by its member(s) (as amended from time to time in accordance with its terms, the "*Operating Agreement*"), which Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization or Chapter 605, *Florida Statutes*. The Operating Agreement shall identify the original members of the Company. Additional persons shall not be admitted to the Company as members except in compliance with the procedures set forth in the Operating Agreement.

ARTICLE V - DURATION

The period of duration for the Company shall be perpetual unless dissolved in accordance with the terms of the Operating Agreement.

ARTICLE VI - MANAGEMENT

The Company shall be managed by one or more managers elected from time to time in accordance with the Operating Agreement (the "*Manager*"). The name and address of the individuals who will serve as initial Managers are **Betty Lynn Landrum Owen** and **Borron James Owen, Jr.** The signature of any one Manager shall be sufficient to bind the Company.

ARTICLE VIII - AMENDMENTS

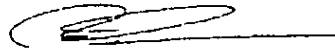
The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by a writing executed by a Manager of the Company.
