## ARTICLES OF ORGANIZATION OF FERDINAND & LUIGIANA HOLDINGS, LLC

The undersigned hereby submits these Articles of Organization (these "Inticles of Organization") for purposes of forming Ferdinand & Luigiana Holdings, LLC, a Florida limited liability company, under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutus.

#### ARTICLE VI - MANAGEMENT

The Company shall be managed by one or more managers elected from time to time in accordance with that Operating Agreement (the "Manager"). The name and address of the individuals who will serve as initial Wanagers are Buppy Lynn Landnum Owen and Borron James Owen, Jr. The signature of any one Manager shall be sufficient to bind the Company.

#### ARTICLE VIII - AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by a writing executed by a Manager of the Company.
