The undersigned, being above the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the laws of the State of Florida, does hereby sign and deliver to the Florida Department of State the following Articles of Organization:

ARTICLE I - NAME

The name of this Florida limited liability company shall be Taurus CD 194 Apopka Hilton GP, LLC, a Florida limited liability company (the "Company").

ARTICLE II - PRINCIPAL OFFICE MAILING AND STREET ADDRESS

The initial principal office mailing and street address of the Company shall be located at 610 North Wymore Road, Suite 200, Maitland, Florida 32751.

ARTICLE III - INITIAL REGISTERED AGENT AND OFFICE

The initial registered agent of this Company shall be Linda G. Kassof, which registered agent has an office located at 610 North Wymore Road, Suite 200, Maitland, Florida 32751.

ARTICLE IV - PURPOSES AND GENERAL POWERS

The general purpose of this Company shall be the transaction of any and all lawful business. 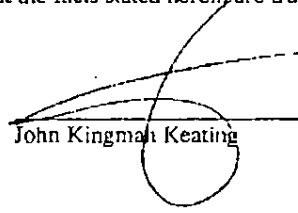
ARTICLE IX - COMMENCEMENT OF EXISTENCE

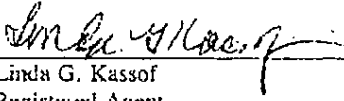
