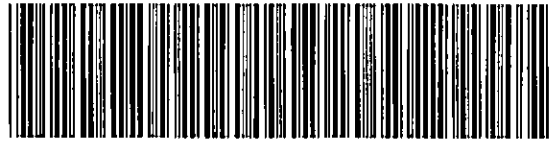




**ARTICLE IX
