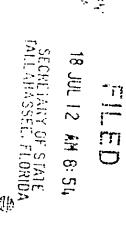

ARTICLES OF ORGANIZATION OF RICHVALE TRADING GROUP LLC

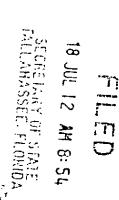
ARTICLE III REGISTERED AGENT AND OFFICE
