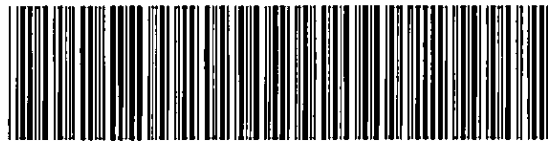

**ARTICLES OF ORGANIZATION
OF

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**






