ARTICLE 1 - NAME

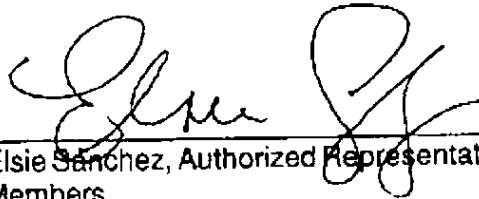

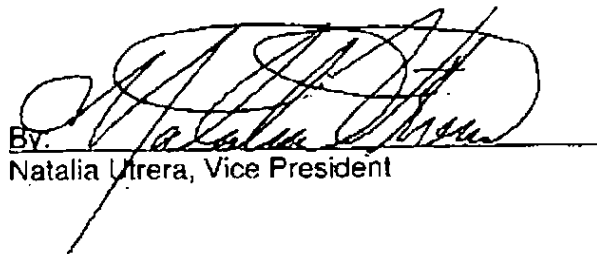
