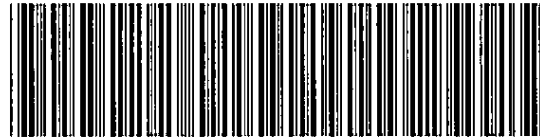

Article IV of the Articles of Organization is hereby amended to remove MELISSA M. HARZ as a Manager so that Article IV reads as follows:


