1. Name. The name of the Limited Liability Company shall be MainSpring Properties, LLC.

2. Duration of Company. The company shall have perpetual duration.

3. Principal Office. The mailing address and street address of the principal office of the Limited Liability Company is 962 Ocean Boulevard, Atlantic Beach, Florida 32233.

4. Registered Agent and Office. The name and street address of the Limited Liability Company's initial registered agent is Kathleen H. Cold, One Independent Drive, Suite 2301, Jacksonville, Florida 32202.

9. The date of the existence of the limited liability shall be the date of the filing of the Articles of Organization by the Department of State of the State of Florida.


10. The Articles of Organization of this limited liability company may be amended in any manner permitted by Chapter 605, Florida Statutes.
