- 2. Identity of the Fraudster: I hereby state that an individual by the name of Jorge Leon Padron committed fraudulent activities against Dixie Landscape, LLC.
- 3. Incident of Fraud: On Friday, September 20, 2024, Jorge Leon Padron filed an illegitimate Amended Annual Report with the Florida Division of Corporations via the Sunbiz.gov website. - 4. Details of the Fraud: In this illegitimate filing, Jorge Leon Padron fraudulently changed both the Registered Agent and the President's name of Dixie Landscape, LLC. to his own. These changes were not authorized by any officer or representative of Dixie Landscape, LLC., and do not reflect the true and legitimate structure of the organization.
- 5. Discovery of Fraud: The fraudulent filing was discovered on September 20, 2024 at which point immediate steps were taken to report and rectify this unlawful action.
- 6. Corrective Action: On Saturday, September 21, 2024, we filed an updated Amended Annual Report with the Florida Division of Corporations to restore the correct Registered Agent and President's name to reflect the legitimate officers of Dixie Landscape, LLC.
