The name of the limited liability company is: Blue Creek Ventures, LLC

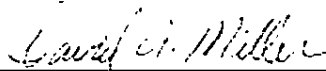
ARTICLE II. ADDRESS

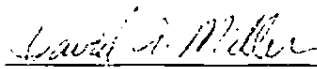
