4. Place of Principal Office: The mailing and street address of the Company's principal office is 4555 Bayshore Blvd NE, St. Petersburg, Florida 33703.

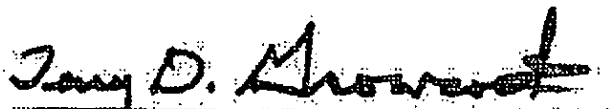

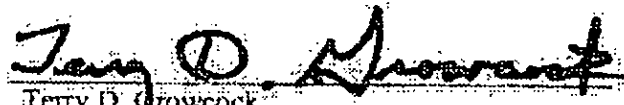
