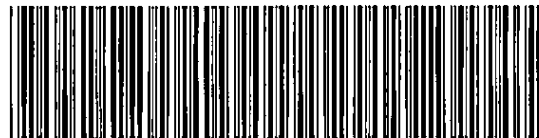

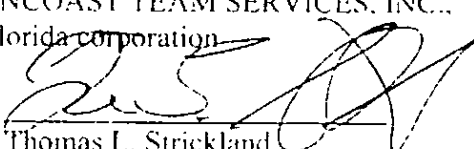

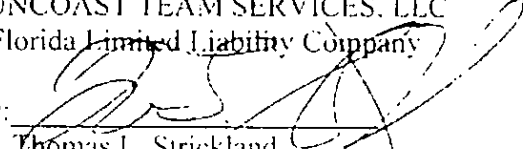
1. Immediately prior to the filing of these Articles of Conversion the business entity's name is Suncoast Team Services, Inc.
2. Suncoast Team Services, Inc. is a Florida corporation, first incorporated under the laws of the State of Florida, on January 25, 1999.
3. The name of the Florida Limited Liability Company as set forth in the attached Articles of Organization is Suncoast Team Services, LLC.
4. These Articles of Conversion shall become effective immediately upon the filing of the Articles of Conversion with the Florida Department of State, the time of such effectiveness being hereinafter called the "**Effective Date**."
