**ARTICLES OF ORGANIZATION

ARTICLE 1
Name

The name of this limited liability company is:

The Company will furnish to any member or assignee, upon request and without charge, a full statement of the restrictions and a copy of the Company's Operating Agreement.

ARTICLE 6Indemnification

The Company shall indemnify its managers and members to the fullest extent authorized by law.
