**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION**

OF

METROPOLITAN NAPLES, LLC

The Articles of Organization for this limited liability company were filed on July 31, 2018 and given Florida document number L18000183911. The Articles of Organization are amended and restated as follows:

ARTICLE I

NAME AND ADDRESS

The name of this Limited Liability Company shall be **Metropolitan Naples, LLC** (the "Company"). The mailing address and street address of the principal office of the Company is c/o 1415 Panther Lane, Naples, Florida 34109.

ARTICLE II

DURATION

The Company shall exist perpetually until dissolved pursuant to a written agreement of all members of the Company, or as provided by law, or as provided in any Operating Agreement.

ARTICLE III
