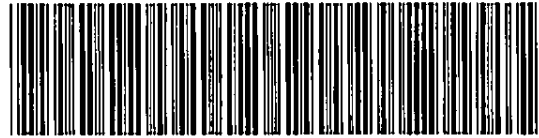

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizers desire to form a limited liability company under the laws of the State of Florida by delivering these Articles of Organization to the Florida Department of State, in accordance with Florida Revised Limited Liability Company Act ("the Act").

SECTION 2 NAME

The name of the limited liability company is **REFLECTING FREEDOM, LLC**, a Florida limited liability company ("the LLC").

SECTION 3 DURATION

The LLC will perpetually exist from the filing date of these Articles of Organization with the Florida Department of State, unless dissolved according to law.

SECTION 4 LLC'S PURPOSE

The LLC's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The LLC has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

This Operating Agreement may be amended from time to time according to its provisions.

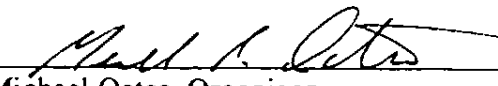
SECTION 12 INDEMNIFICATION AND LIABILITY

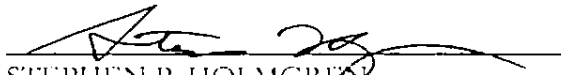
