**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
MONUMENT COMMERCIAL BUILDING INSPECTIONS, LLC**

Pursuant to the Florida Revised Limited Liability Company Act (the "Act") and specifically Florida Statute § 605.0202, Monument Commercial Building Inspections, LLC (the "Company") whose Articles of Organization were first filed in Florida effective as of July 31, 2018, hereby submits these Amended and Restated Articles of Organization to replace entirely any previously filed Articles of Organization.

ARTICLE I: NAME

The name of the limited liability company is Monument Commercial Building Inspections, LLC.

ARTICLE II: ADDRESS

ARTICLE IV: DURATION AND EXISTENCE; EFFECTIVE DATE

The Company will exist perpetually, commencing on the date of the filing of these Amended and Restated Articles of Organization with the Florida Department of State.

ARTICLE V: MANAGEMENT

(Managed by Managers)

The Company shall be managed by a Board of Managers (which shall have duties, powers and authority similar to that of a Board of Directors) and shall operate through officers elected by the Board of Managers, all as provided in the Limited Liability Company Operating Agreement of the Members (the "**Operating Agreement**"). Accordingly, managers who may, but need not be, Members, manage the Company. The persons making up the Board of Managers are designated in the Operating Agreement, as amended from time to time. ARTICLE VII: OWNERSHIP

Ownership interests in the Company by its Members may, but need not, be evidenced by certificates signed by the president or any vice-president of the Company and by the secretary or any assistant-secretary of the Company. Transfers of certificates are restricted by the terms of the Limited Liability Company Operating Agreement among the Members of the Company. The Members of the Company shall have the right to admit additional members pursuant to the terms and conditions contained in the Operating Agreement of the Company; any new member agrees to be bound by and to such Operating Agreement.

ARTICLE VIII: OPERATING AGREEMENT

An Operating Agreement, the power to adopt, alter, amend or repeal which shall be vested in the Members of the Company, shall govern the management, operation and ownership of the Company.

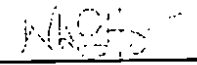
ARTICLE IX: LIMITED LIABILITY

ARTICLE X: INDEMNIFICATION

To the fullest extent not prohibited by law, the Company shall advance indemnification expenses for actions taken by such person in the capacity of manager or officer.

IN WITNESS WHEREOF, the undersigned has executed these Amended and Restated Articles of Organization this 31st day of August, 2018, and in accordance with Section 605.0201, Florida Statutes, acknowledges that this document constitutes an affirmation under penalties of perjury that the facts stated herein are true and correct and further affirms that the Company has or will have at least one member at the time these Amended and Restated Articles of Organization become effective.
