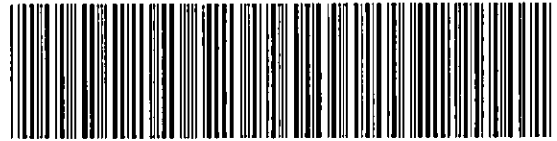

The name of the Florida Limited Liability Company is **TWS Newberry, LLC**.


Article II

The name of the registered agent is **Thomas E. Whitney** and whose Florida street address is **530 S. Main Street, Winter Garden, FL 34787**.


