**ARTICLES OF ORGANIZATION
OF

The undersigned, Melinda Sue Urschler, a natural person competent to contract and an authorized representative of Zae Yara Collective, LLC, hereby presents these Articles of Organization as the Articles of Organization of Zae Yara Collective, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME

The name of the limited liability company is Zae Yara Collective, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II – PRINCIPAL OFFICE ADDRESS

ARTICLE III – PURPOSE AND POWERS

The Company shall be managed by a manager in accordance with the terms of the Operating Agreement for the Company. The name and address of the initial manager of the Company is as follows:




