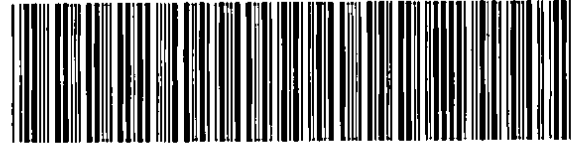

**ARTICLES OF MERGER
FOR
FLORIDA LIMITED LIABILITY COMPANY
(ARBOR LANDING @ LAKE JACKSON, LLC)**

THE UNDERSIGNED hereby make these Articles of Merger pursuant to Section 605.1021, et seq., Florida Statutes, and applicable provisions of the Florida Revised Limited Liability Company Act (the "Act"), for the purpose of merging SUMMERFIELD PUD, LLC, a Florida limited liability company, with and into ARBOR LANDING @ LAKE JACKSON, LLC, a Florida limited liability company, f/k/a Arbor Landing @ Lake Jackson II, LLC. Said limited liability companies are sometimes referred to collectively herein as the "Constituent Companies" and each, separately, as a "Constituent Company".

1. The exact name, address, jurisdiction, form/entity type, entity identification number and date of formation for each merging entity and the surviving entity are as follows:

The Plan and Agreement of Merger and Reorganization dated July 7, 2021 (the "Plan") and these Articles have been duly approved and executed by each of the Constituent Companies in accordance with Sections 605.1021 - 605.1026, Florida Statutes. The Plan and these Articles have been duly approved by the unanimous consent of the members, respectively, of each of the Constituent Companies, and such consent is sufficient to authorize the merger of the Constituent Companies as provided for in the Plan.

3. As to each of the Constituent Companies, the Plan and the performance of its terms have been duly authorized by all actions required under (i) the laws of the jurisdiction

under which such Constituent Company is organized; (ii) the articles of organization and operating agreement of Summerfield PUD, LLC; and (iii) the articles of organization and operating agreement of Arbor Landing @ Lake Jackson, LLC, f/k/a Arbor Landing @ Lake Jackson II, LLC.

4. The surviving Constituent Company shall be Arbor Landing @ Lake Jackson, LLC, a Florida limited liability company. There shall be no amendments to the Articles of Organization of Arbor Landing @ Lake Jackson, LLC, as a result of the merger.

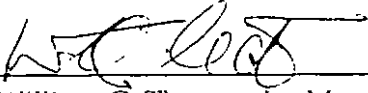

6. The effective date of the merger shall be July 15, 2021. The merger shall be deemed effective on the entire day of July 15, 2021.

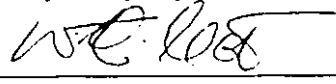
