**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF

These Articles of Amendment to Articles of Organization (this "**Amendment**") for OPL Logistics LLC (*formerly known as Vipre Transport LLC*), a Florida limited liability company (the "**Company**"), are being filed pursuant to the provisions of section 605.0202, Florida Statutes. The Company hereby adopts this Amendment to its (i) Articles of Organization filed with the Florida Secretary of State on August 8, 2018, and (ii) Articles of Amendment to Articles of Organization filed with the Florida Secretary of State on September 21, 2021, under Document Number L18000190077 (collectively, the "**Original Articles**").

This Amendment is submitted to amend the following:

A. The Original Articles are hereby replaced in their entirety with the following:

ARTICLE I – Name

The name of the limited liability company is OPL Logistics LLC (the "**Company**").

The Company shall be managed by its member, as set forth in the Company's Operating Agreement, and is therefore a member-managed Company. The Company's initial member-manager shall be:

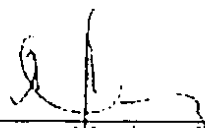
