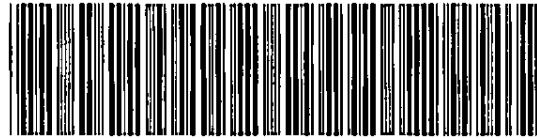

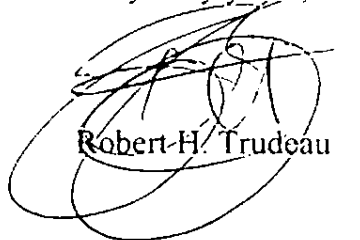

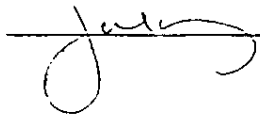
Article VI
