

The undersigned, for the purpose of forming a limited liability company unger the Florida Limited Liability Company Act, Florida Statutes Chapter 605 heraby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be CFP OF OCAL ("Company").

ARTICLE 2 - ADDRESS
