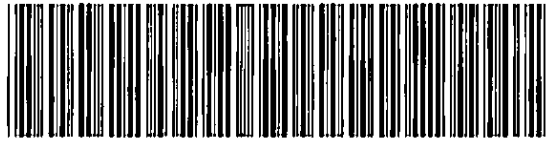

These Articles of Conversion are submitted with respect to the conversion of **AVE TOCCOA, LLC**, a Florida limited liability company (the "Florida LLC"), into **AVE TOCCOA, LLC**, a Georgia limited liability company (the "Georgia LLC"), in accordance with Section 605.1045, Florida Statutes and Section 14-11-212 of the Georgia Code.

1. The Florida LLC has been converted into the Georgia LLC in compliance with Chapter 605, Florida Statutes, and the conversion complies with Section 14 of the Georgia Code.

2. The plan of conversion was approved by the Florida LLC in accordance with Sections 605.1041-605.1046, Florida Statutes.

3. The address of the principal office and mailing address of the Georgia LLC under the laws of the State of Georgia is 14645 Round Valley Drive, Sherman Oaks, California 91403.


4. The Georgia LLC will not be authorized to transact business in the State of Florida, and appoints the Florida Department of State as its agent for service of process in a proceeding to enforce obligations of the Florida LLC, including any appraisal rights of its members under Sections 605.1006 and 605.1061-605.1072 of the Florida Statutes, and the Florida Department of State may use the following street and mailing address for purposes of Section 605.0117, Florida Statutes: 14645 Round Valley Drive, Sherman Oaks, California 91403.

5. The Georgia LLC has agreed to pay any members having appraisal rights the amount to which such members are entitled under Sections 605.1006 and 605.1061-605.1072 of the Florida Statutes.
