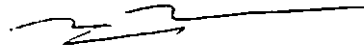

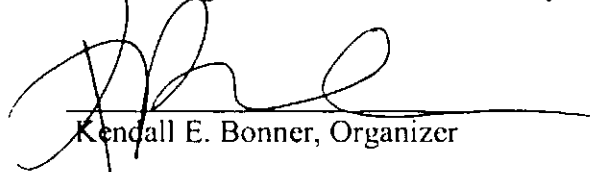
Liability
