AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF

The Articles of Organization of Parramore Asset Stabilization Fund, LLC (the "Company") were filed with the Florida Department of State on August 16, 2018, effective on August 15, 2018, and assigned Florida Document Number L18000196169. Pursuant to the provisions of Section 605.0202 of the Florida Statutes, the Company hereby adopts the following Amended and Restated Articles of Organization of the Company:

ARTICLE I - NAME OF COMPANY

The name of the limited liability company is Parramore Asset Stabilization Fund; L

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - SECTION 501(C)(3) ORGANIZATION

No part of the net earnings of the Company shall inure to the benefit of any private person, except that the Company shall be authorized and empowered to pay reasonable compensation for services rendered to the Company and to make payments and distributions in furtherance of the purposes set forth in this Article III. No substantial part of the activities of the Company shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the Company shall not participate in or intervene in any political campaign (including publishing or distributing statements) on behalf of or in opposition to any candidate for public office. The Company shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Code Section 501(c)(3), or (b) by an organization, contributions to which are deductible under Code Section 170(c)(2).

The transfer of a membership interest in the Company is prohibited except for a transfer approved by all of the members of the Company to an organization exempt from tax pursuant to Code Section 501(c)(3), or to the federal government or a state or local government, for a public purpose.

Upon the dissolution of this Company, after the payment or provision for the payment of all of the liabilities of this Company, all of the assets of this Company shall be distributed for one or more exempt purposes within the meaning of Code Section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose.
