**ARTICLES OF ORGANIZATION

The undersigned, Robert Hinojosa, a natural person competent to contract and an authorized representative of LJAS ENTERPRISES, LLC, hereby presents these Articles of Organization as the Articles of Organization of LJAS ENTERPRISES, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**




