The undersigned, pursuant to the authority granted under Chapter 605 of the Florida Statutes, and Fla. Stat. § 605.0202 of the Revised Florida Limited Liability Company Act (the "Act"), hereby presents the following amended and restated Articles of Organization for the Company, and in doing so does hereby certify that the following articles to hereby supercede, amend and correct any previous articles or provisions for the Company in any previous filing to date:

**ARTICLE I — Name:**

The name of the Limited Liability Company organized under these Articles shall be:

**ROGALIO, LLC.**

**ARTICLE II — Principal Office Address:**

The street address of the principal office and mailing address of the Limited Liability Company is: **2719 Hollywood Blvd., Suite A-1672, Hollywood, FL 33020.**

**ARTICLE III — Effective Date and Duration:**

The effective date of this Limited Liability Company shall be September 1, 2018 and the period of duration for the Limited Liability Company shall be perpetual from the date of the issuance of a Certificate of Organization by the State of Florida.

**ARTICLE IV — Members and Management:**

This Limited Liability Company shall have at least one member and may admit additional members in accordance with these Articles and any duly executed Operating Agreement agreed upon by the Member(s). This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be **manager-managed**. The managers may be designated as the manager, general manager, operations manager, president, secretary, and/or treasurer of the Company, and may also be designated as vice-presidents, assistant secretaries, and assistant treasurers, and shall have the authority normally

associated with these positions under corporate law. The Company may, upon the unanimous consent of the members, also designate persons as directors under the Operating Agreement who shall act in a manner similar to the directors of a corporation. The members, at a meeting of the members held not less than annually *unless otherwise specified in the Operating Agreement*, in person or by proxy, shall designate the manager(s), who may also be one or more of the members, and the positions that the manager(s) will hold. The initial manager(s), who shall serve until the first annual meeting of the members or until their successors are elected and qualify, and their designations shall be as follows:

**ARTICLE V — Admission of Additional Members:**

The right, if given, of the member(s) to admit any additional member(s) and the terms and conditions of the admissions shall be governed by the Operating Agreement established by the Member(s) for the Limited Liability Company contemporaneously with or immediate after the organization of this company, as amended. Unless otherwise set forth in any such Operating Agreement, no additional members shall be admitted unless all members, (including any additional members other than original members) shall unanimously agree, and then only on such terms and conditions as shall be agreed upon unanimously.

**ARTICLE VI — Members' Rights to Continue Business**

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of one or all of the members, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, shall be governed by the Act, unless otherwise specified by an Operating Agreement established by the Member(s) for the Limited Liability Company, as amended.

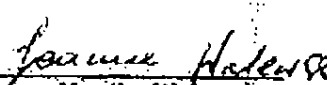

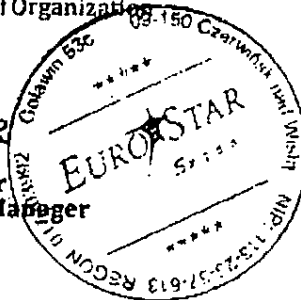

This Limited Liability Company shall indemnify any member, or any former member, to the full extent permitted by law unless otherwise specified in an applicable Operating Agreement.

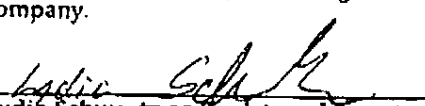
