OPERATING AGREEMENT

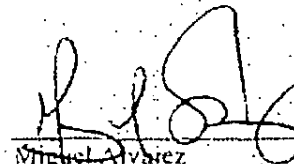

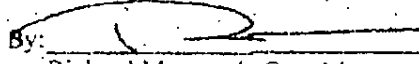
