**DESIGNATION OF REGISTERED AGENT**


The name and address of the registered agent and office of the Company shall be **Greg Orick, II**, 27171 Driftwood Dr. Bonita Springs, FL 34135.

**MANAGEMENT OF COMPANY BUSINESS**


The Company's day to day business will be managed by a manager and is therefore a manager-managed company. **Greg Orick, II** will be the initial manager of the Company.
