**ARTICLES OF ORGANIZATION
OF

The undersigned, Paul Register, a natural person competent to contract and an authorized representative of MICS III, LLC, hereby presents these Articles of Organization as the Articles of Organization of MICS III, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I – NAME
