ARTICLES OF ORGANIZATION

OF

DIXIE BUNGALOW, LLC

The undersigned acting as the organizer of **DIXIE BUNGALOW, LLC**, under the Florida Limited Liability Company Act, Chapter 605, Fla. Stat., adopt the following Articles of Organization: —

ARTICLE I - Name:

The name of the limited liability company is: **DIXIE BUNGALOW, LLC** (the "Company").

ARTICLE II - Address:

The Company shall admit new Members only upon the unanimous written consent of all then existing Members of the Company.

ARTICLE VI - Initial Registered Agent and Office:

The initial registered agent for the Company shall be David B. Norris, Esq., Cohen Norris Wolmer Ray Telepman Cohen, and the street address of the Company's initial registered office is 712 U.S. Highway One, Suite 400, North Palm Beach, FL 33408.

ARTICLE VII - Amendments:

The Company reserves the right to amend any provision of these Articles of Organization.

ARTICLE VIII - Indemnification:

Each individual or entity who is or was a member or manager of the Company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a member or manager of the Company ("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the indemnification conferred in this Article, the Indemnitee shall also be entitled to have paid directly by the Company the expenses reasonably incurred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conferred in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a member, manager or officer existing at the time of such repeal or amendment.


**CERTIFICATE OF DESIGNATION OF
