Article I. Name and Purpose

The voting members shall have complete discretion on when and if to approve any distribution of profits.

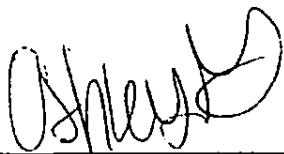
