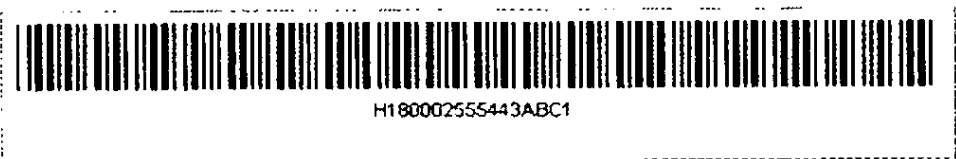

The name of the limited liability company is: BLUEFIN CARPET COMPANY, LLC


ARTICLE II. ADDRESS


