**ARTICLES OF ORGANIZATION
OF
eProdiG, LLC**

I, the undersigned natural person of the age of eighteen (18) years or more, acting as organizer of a limited liability company under Section 605.0201 of the Florida Revised Limited Liability Act (the "Act"), do hereby adopt the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company is eProdiG, LLC (the "Company").

ARTICLE II

ARTICLE III

The effective date of these Articles of Organization shall be August 30, 2018.

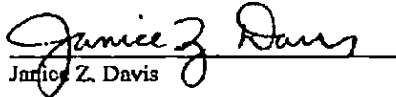
ARTICLE VI

Except as and to the extent the Bylaws specifically provide otherwise, a member or manager shall not be liable for the debts, obligations or liabilities of the Company including under a judgment, decree or order of a court. No manager of the Company shall be liable, personally or otherwise, in any way to the Company or its members for monetary damages caused in any way by an act or omission occurring in the manager's capacity as a manager of the Company. Any repeal or modification of this Article or the Bylaws shall be prospective only, and shall not adversely affect any limitation of the personal liability of a manager or member of the Company at the time of the repeal or modification.

ARTICLE VII

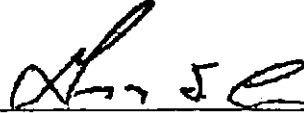
Any action required to be taken at any annual or special meeting of the members of the Company, and/or any action that may be taken at any annual or special meeting of the members of the Company, may be taken without a meeting, without prior notice, and without a vote, if a consent or consents in writing, setting forth the action so taken, shall be signed by a member or members having not less than the minimum number of votes that would be necessary to take such action at a meeting at which all members entitled to vote on the action were present and voted. Any such action shall be taken in accordance with any applicable provisions of the Act.
