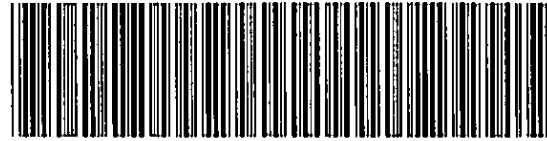

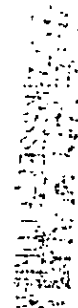

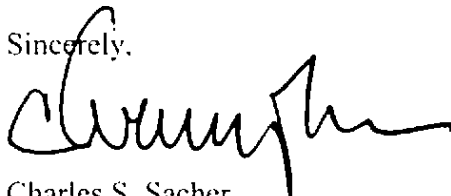

ARTICLE I  
NAME

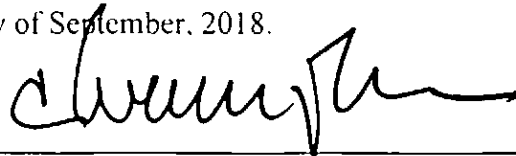

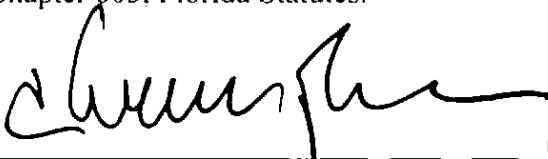
