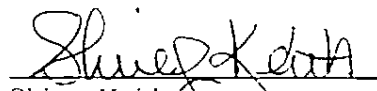

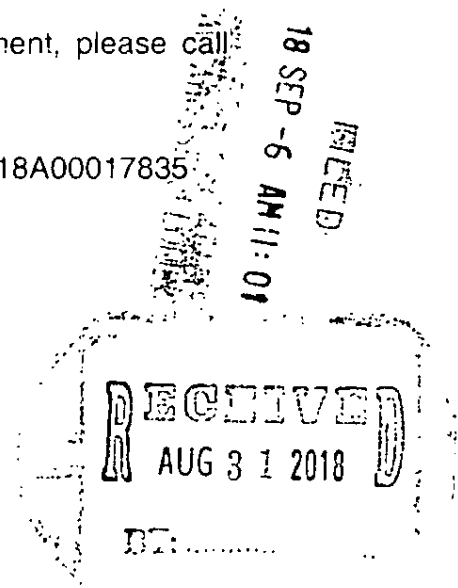

Mailing Address

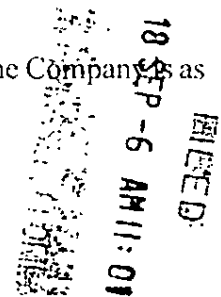

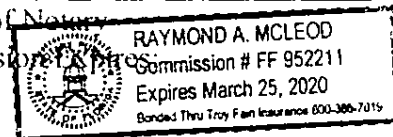

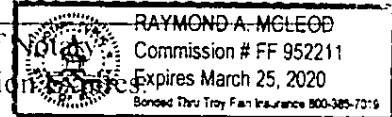
