ARTICLE I

The duration of this limited liability company shall be perpetual.

ARTICLE VIII

The date of the existence of the limited liability shall be the date of the filing of the Articles of Organization by the Department of State of the State of Florida.

ARTICLE IX

The Articles of Organization of this limited liability company may be amended in any manner permitted by Chapter 605, Florida Statutes.

ARTICLE X

Management of the limited liability company shall be vested in a manager or managers who shall be elected annually by the members in the manner prescribed by and provided in the regulations of the limited liability company. The manager or managers may or may not be members. The manager or managers shall also hold the offices and have the responsibilities accorded to them by the members and set out in the operating agreement of the limited liability company. All rights of members of this limited liability company shall be in proportion to their contributions to the capital of the limited liability company, as adjusted from time to time to properly reflect any additional contributions or withdrawals by the members.

ARTICLE XI

The power to adopt, alter, amend, or repeal the regulations of this limited liability company shall be vested in the manager or managers of the company. Regulations adopted by the manager or managers maybe repealed or altered; new regulations may be adopted by the members; and the members may prescribe in any regulations made by them that such regulations may not be altered, amended or repealed by the manager or managers. The regulations may contain any

consistent with law or the Articles of Organization.


ARTICLE XII

ARTICLE XIII

The interest of a member in the limited liability company may be transferred or
assigned as provided in the operating agreement; however, if all of the other members of this limited
liability company other than the member proposing to dispose of his or its interest do not approve of
the proposed transfer or assignment by unanimous written consent, the transferee of the interest of
the member shall have no right to participate in the management of the business and affairs of this
limited liability company or to become a member. Such transferee shall be entitled to receive only
the share of profits or other compensation by way of income and the return of contributions to which
that member otherwise would be entitled.


