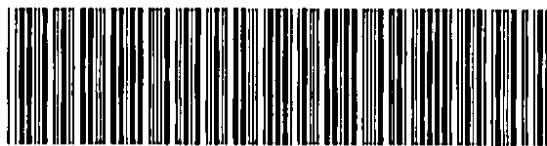

**ARTICLES OF AMENDMENT OF THE  
ARTICLES OF ORGANIZATION OF  
ZAHRADA I LIMITED LIABILITY COMPANY**

**ARTICLE I**
