

ARTICLES OF ORGANIZATION

The Company also shall pay or reimburse all reasonable expenses incurred by a present or former member or agent of the Company in connection with any threatened, pending or completed action, suit or proceeding (whether civil, criminal, administrative or investigative) in which the present or former member or agent is a party, in advance of the final disposition of the proceeding, to the fullest extent permitted by, and in accordance with the applicable requirements of, Florida law as it may be amended from time to time.

The Company shall be formed on the date these Articles of Organization are accepted and recorded by the Secretary of State of the State of Florida and shall continue in existence perpetually unless and until dissolved in accordance with the Act or the Operating Agreement.
