### **OASIS FAMILY FARM LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be **OASIS FAMILY FARM LLC** ("Company").

#### **ARTICLE 2 - ADDRESS**

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




