

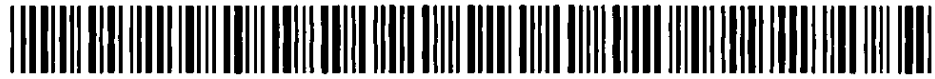


**ARTICLES OF ORGANIZATION
