The undersigned, desiring to amend the Articles of Organization for OPEN ACCESS URGENT CARE, LLC, a Florida limited liability company, under and pursuant to Chapter 605, Florida Statutes, does hereby adopt the following Articles of Amendment to the Articles of Organization for such company:

1. The Articles of Organization for OPEN ACCESS URGENT CARE, LLC were filed on September 12, 2018 effective as of September 9, 2018 and assigned document number L18000217276.
2. The following amendment to the Articles of Organization was adopted by the limited liability company:

Article IV is hereby deleted in its entirety and replaced with the following:

3. The following amendment to the Articles of Organization was adopted by the limited liability company:


