**ARTICLES OF ORGANIZATION
OF

1. Name. The name of this limited liability company is **POPS FAMILY, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

6. Purpose; Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal an Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
