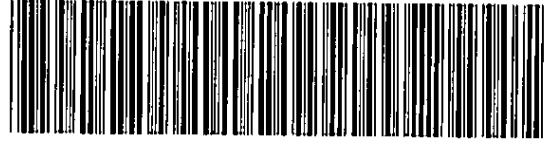

ARTICLES OF ORGANIZATION  
OF  
BIG BEACH PROPERTIES, LLC

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, adopts the following Articles of Organization:

ARTICLE I

NAME

The name of the limited liability company is **BIG BEACH PROPERTIES, LLC**.

ARTICLE II

ADDRESS

The principal office and mailing address of the limited liability company shall be 13225 Morning Sun Drive, Jacksonville, Florida 32225.

ARTICLE III

DURATION

The duration of the limited liability company shall be fifty (50) years, and shall commence on the date that these Articles are filed with and by the Florida Department of State.

ARTICLE IV

MEMBERS AND MANAGEMENT

The sole member of the limited liability company is **John S. Smith**, who shall manage the limited liability company in accordance with an Operating Agreement to be adopted by such member.

ARTICLE V

ADMISSION OF ADDITIONAL MEMBERS

Additional member(s) shall be admitted upon the prior written approval of then existing members who own a majority of the interests in the company.

## **ARTICLE VI**

### **MEMBERS' RIGHTS TO CONTINUE BUSINESS**


The remaining member(s) of the limited liability company shall have the right to continue the business on the death, retirement, resignation, expulsion or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, provided each remaining member consents thereto in writing.

## **ARTICLE VII**

### **INITIAL REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of the limited liability company is 13225 Morning Sun Drive, Jacksonville, Florida 32225, and the name of the initial registered agent of the limited liability company at that address is John S. Smith. By executing these Articles as the organizing member and initial registered agent of the limited liability company, John S. Smith hereby accepts his appointment and agrees to act in this capacity and to comply with the provisions of all statutes relating to the proper and complete performance of his duties, and further states that he is familiar with and accepts the obligations of his position as registered agent.

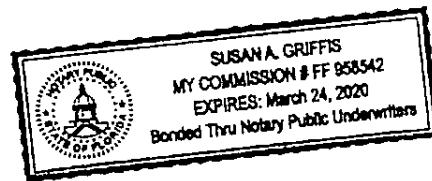
