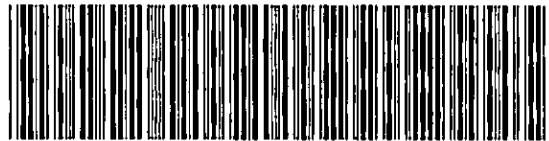

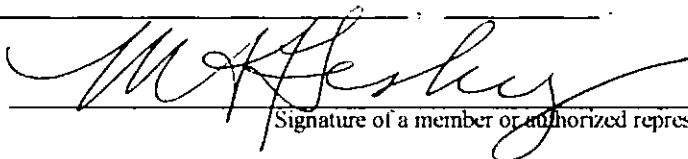

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

This matter came before the Court for Final Hearing on September 4, 2019. Present were the Petitioner/Wife, MICHELLE ANNE JONES and her counsel, ANA-MARIA CARNESOLTAS, ESQ. of the Law Office of Ana-Maria Carnesoltas, P.A.

FINDINGS OF FACT

1. The Wife has been residents of Hillsborough County, Florida, for more than six months prior to the filing of this Petition. Neither party is a member of the military service of the United States or of any other nation. The Court has jurisdiction over the parties.
2. There are no children born of this marriage and the Wife is not pregnant.
3. On May 6, 2019, the Parties voluntarily entered into a Marital Settlement Agreement which settles all issues relative to the equitable distribution of their marital assets and liabilities. Both Parties have requested that the Court ratify the Marital Settlement Agreement and incorporate the same by reference into the Final Judgment.
4. ~~The Former Wife has requested that her name be changed to MICHELLE ANNE~~
~~GESKEY.~~
5. The marriage of the parties is irretrievably broken and there is no chance of reconciliation.

Therefore it is,

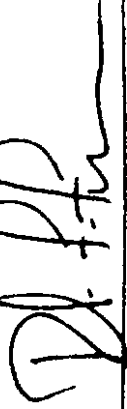
ORDERED AND ADJUDGED
