ARTICLE VI – MANAGEMENT

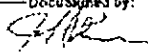

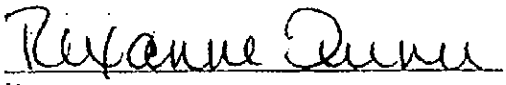
